BYLAW No. 12, 1999

A Bylaw for the Levying of Tax Rates for Municipal, Regional Hospital and Cariboo Regional District Purposes for the 1999 year.

WHEREAS Sections 331 to 333 of the Municipal Act allow a Municipal Council to impose rates on all taxable land and improvements according to their assessed value to provide the money required for various lawful purposes;

THEREFORE NOW the Council of the District of Wells, in open meeting assembled, enacts as follows:

1. The following rates are imposed and levied on all taxable land and improvements for the year 1999:
 - a. For the lawful general purposes of the District on the value of land and improvements taxable for General Purposes, rates appearing in Column "A" of the Schedule forming a part hereof.
 - b. For debt purposes on the value of land and improvements taxable for General Purposes, rates appearing in Column "B" of the Schedule attached hereto and forming a part hereof;
 - c. For total municipal purposes on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in Column "C" of the Schedule attached hereto and forming a part hereof;
 - d. For hospital purposes on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in Column "D" of the Schedule attached hereto and forming a part hereof;
 - e. For purposes of the Cariboo Regional District on the value of land and improvements taxable for Regional Hospital District Purposes, rates appearing in Column "E" of the Schedule attached hereto and forming a part hereof;
 - f. For purposes of the Cariboo Regional District – Rural Refuse, on the value of Land and Improvements taxable for General purposes, rates appearing in Column "F" of the Schedule attached hereto and forming a part hereof.
2. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
3. This Bylaw shall be cited for all purposes as "Tax Rates Bylaw No. 12, 1999.
