

## **DISTRICT OF WELLS**

### **SEWER LOCAL SERVICE AREA AMENDMENT** **BYLAW NO. 69, 2004**

**A Bylaw to amend Cariboo Regional District Bylaw No. 2686, cited as “Wells Sewer Local Service Establishment Bylaw No. 2686, 1992;**

**WHEREAS**, Cariboo Regional District Bylaw No. 2686, cited as “Wells Sewer Local Service Establishment Bylaw No. 2686, 1992 established a local service area in Wells to provide sanitary sewer service;

**AND WHEREAS**, Cariboo Regional District Bylaw No. 2980, cited as “Wells Sewer Local Service Area Establishment Amendment Bylaw No. 2980, 1995 amended the service area specified in Cariboo Regional District Bylaw No. 2686;

**AND WHEREAS**, the service area for the District of Wells sanitary sewer system has been expanded in 2004 by the construction of new infrastructure to serve additional properties;

**AND WHEREAS**, the costs of constructing, operating and maintaining the District of Wells sanitary sewer system are apportioned to those properties within the “Wells Sewer Local Service Area”;

**AND WHEREAS**, pursuant to Section 12 of the Letters Patent of the District of Wells, the Council of the District of Wells may enforce, amend, or repeal any Bylaw of the Cariboo Regional District in force and having application to the District of Wells at the time of incorporation;

**NOW THEREFORE**, be it resolved that the Council of the District of Wells, in open meeting, **HEREBY ENACTS AS FOLLOWS:**

- 1.** Cariboo Regional District Bylaw No. 2980 cited as “Wells Sewer Local Service Area Establishment Amendment Bylaw No. 2980, 1995” is hereby repealed.
- 2.** The boundaries of the “Wells Sewer Local Service Area” as established by “Wells Sewer Local Service Establishment Bylaw No. 2686, 1992 are hereby amended to include the properties as detailed on Schedule “A”, attached hereto.
- 3.** Schedule “A” of Cariboo Regional District Bylaw No. 2686 is hereby deleted and Schedule “A” attached hereto is substituted therefore.
- 4.** This Bylaw may be cited for all purposes as "Sewer Local Service Area Amendment Bylaw No. 69, 2004".

5. This Bylaw shall come into effect upon its adoption.

READ A SECOND TIME THIS 16th DAY OF NOVEMBER, 2004.

READ A THIRD TIME THIS 16th DAY OF NOVEMBER, 2004.

ADOPTED THIS 7<sup>th</sup> DAY OF DECEMBER, 2004, BY A MAJORITY DECISION OF ALL MEMBERS OF THE DISTRICT OF WELLS COUNCIL PRESENT AND ELIGIBLE TO VOTE.
